### **PUBLIC COMMENTS - NONE**

**GUEST SPEAKER** - <u>Kyle Snyder</u>, PA Broadband Development Authority, gave a presentation about all of the different broadband programs. The PA Broadband Authority was signed into law in 2021 and is a part of DCED. There is a board of eleven members that is charged with distributing infrastructure money. Federal money is available from three different funds. There is a fund to expand the infrastructure; another to provide digital equity; and a fund to buildout the "middle mile". Each state received one hundred million dollars to bring internet to the unserved and underserved. Underserved is defined as areas that have slow internet speeds. Chris Dietz asked if there are any current local projects. Kyle said that the only current project is the Comcast partnership project with Dauphin County. John Orr said that there is a DCED meeting about broadband on April 12<sup>th</sup>. Kyle said that the current time frame is some money will become available this spring and the rest of the funds will be available in 2024.

<u>Jerry Duke</u>, TCRP, talked about the land development approval process. Currently, six Upper Dauphin municipalities do not have their own land development plans. These areas are under County approval and the County asks the municipalities for local concerns and comments. Jerry said the TCRP is there to also help the municipalities that have SALDOs. He offered to have a COG training exercise.

## **OLD BUSINESS -**

Jeff Enders said that there were no changes in the local EMS coverage. Bob Stoner said that the anticipated Millersburg-Halifax ambulance merger seems to be faltering.

We are still looking for more members for the COG UCC appeals board. Several names were suggested.
